**SPECIAL TERMS AND CONDITIONS FOR THE WORK OF ANNUAL  
MAINTENANCE CONTRACT OF 6 UPS SYSTEMS FOR ONE YEAR  
UNDER THE CONTROL OF ELECTRICAL WING  
OF KSCB**

---

- 1) The AMC shall cover comprehensive contract for repairs & cost of replacement of all parts of the UPS including PCB's, Components etc. However the AMC does not include cost of replacement of batteries for UPS of 3 KVA ratings.
- 2) The service personnel shall rectify the complaints received from the office on the same day. If necessary, they will be required to stay back after office hours and even on holidays too, to attend to any emergency work.
- 3) If the faulty Components/UPS(s) are not rectified within the same working day. Necessary stand by components/UPS(s) of the same KVA rating shall be provided on the following day for smooth functioning of the work. If the original components is not rectified till the expiry of the contract, either the cost of repairs of the equipments be by the contractor or the stand by supplied by the contractor not be reclaimed.
- 4) Preventive maintenance such as checking the general performance of UPS systems and DC stand by sources, filling of distilled water & application of white petroleum jelly for non sealed type UPS etc., shall be done twice in a quarter.
- 5) The successful bidder should maintain Log Register/Service Reports of all calls attended /Pending issues, preventive maintenance records and details of all replacement of spares. A separate log shall be maintained for preventive maintenance.
- 6) No Component(s)/Spare(s) etc shall be removed without informing the competent Authority/Bank.

- 7) Payment will be based on half yearly Advance 2<sup>nd</sup> payment will be done only after satisfactory completion of half year.
- 8) For all maintenance /installation TA/DA any other allowances will not be paid by the Bank.
- 9) The AMC shall be in force for 12 months from ..... to ..... before contractor should be executed the agreement in the prescribed format.
- 10) Conveyance, loading and unloading of standby and breakdown systems shall be arranged by the contractor at his own cost.
- 11) The Bank shall have the unfettered right to cancel the AMC contract at any point of time if the quality/service rendered by the vendor is not find satisfactory and liable to pay compensation to the Bank.
- 12) Any disputes which may arise between the Vendor and the Bank under this agreement shall be referred to Arbitration as per the arbitration clause as contemplated under the Kerala Co-operative Societies Act 1969. Also the decision and award of the Arbitrator shall be final and binding on the Vendor and the Bank.
