If any indefinite delay in obtaining sufficient power and commissioning the units 90% of the payment will be released to the supplier.**
8. The single phase air-conditioners should have a comprehensive warranty of 1 year + additional warranty of 5 years for the compressor.
9. All Civil works under supplier's scope and wall openings made if any should be sealed using cement mortar only and should be finished to the plastering level.
