Terms and Conditions

- 1 All security products will be supplied with BIS label on it. With complete details as engraved by BIS. The product should confirm to IS : 11188 and its revised versions as applicable.
- 2 The vendor agrees for random testing of their product bought by the bank at the current BIS test house.
- 3 The vendor should have valid BIS licence for the product/s supplied. Copy of the license to be enclosed and the product should have ISI/BIS marked label. Technology/description like "as per ISI/BIS" should not be accepted, vendor should have in house lock manufacturing in Mandatory.
- 4 The vendor shall make own arrangement for transportation and delivery of the equipment upto the given location-branch/office. The delivery of the strong room door at branch inclusive of all charges, GST, discount if any, etc.
- 5 In case of any damage to the above items before handing over the equipment, the equipment is to be replaced or made good at the supplier expenses to the entire satisfaction of the Bank. In case of delay in rectification of defect, the bank shall be free to appoint another agency to get the job done at vendor's risk and cost.
- 6
 - (a) At any point of time if it is observed that security product supplied by the vendor do not meet the standards of BIS or is sub-standard, bank will be at liberty to blacklist the vendor from supplying any product to the bank in future.
 - (b) The delivery and installation of the strong room door and accessories should be completed within 4 weeks subject to site readings.
- 7 The firm should not have been blacklisted by any banks in the last 10 years.
- 8 The payment of the bill/s will be made by our Head Office, after satisfactory receipt of the goods and its installations.
- 9 The amount to be quoted in figures as well as in words in case there is any variance in these two rates, the amount; written in words shall be taken as final;
- 10 All alterations in the tender should be initiated by the authorized signatory. Over writing may invite disqualification of the tender.

- 11 The rate quoted shall remain valid for a period of 3 months i.e. from the date of bid opening. No escalation of in the rates will be allowed under any circumstances.
- 12 Any dispute arising in this contract/work order shall be subject to the arbitration provisions of Kerala Co-operative Societies Act 1969.
